#### Minutes

**Present:** 

The minutes of the Committee's meeting on 30 July were confirmed as a correct record.

#### Introduction to new district team members

Group Managers and Community Risk Manager from the new district team introduced themselves to the LAC, in preparation for working alongside each other in the Northland community.

### **District update**

The District Manager and Community Risk Manager updated the Committee on recent incidents and work being carried out in Te Tai Tokerau. COVID-19 restrictions are having an ongoing effect on Fire and Emergency, in particular on recruiting and training. It was noted that Whangarei Airport is looking to recruit an onsite brigade, such as Bay of Islands Airport has, and that similar arrangements with Fire and Emergency will need to be agreed through a MOU.

### **Community engagement**

The Committee discussed community engagement undertaken since its previous meeting in July. COVID-19 restrictions have curtailed engagement to some degree.

An LAC member accompanied the District Manager and team members on a visit to Rāwhiti to inspect a proposed alternate site for a new fire station and to discuss viability and process for Fire and Emergency consideration. The meeting indicated that a feasibility study and further discussion with the landowner should be undertaken. The LAC member will work with the Group Manager on a community consultation process, to ensure the new site has the support of the community prior to the project proceeding.

At a regular Kaipara Police-Iwi Liaison meeting iwi noted that, particularly under COVID levels 3 and 4, there is a shortage of skilled people available to lift tapu from sites of motor vehicle accidents. The question of capacity to support first responders with whakawātea of sites will be raised at Fire and Emergency's Group and COVID meetings.

### **Engagement planning**

Work and communications will continue between the LAC, Fire and Emergency management CDEM and Te Uri o Hau in establishing a marae-based community programme dealing with response, education and planning for recovery in the North Western Kaipara area.

A planning session will be scheduled for the February LAC meeting. District leaders will present their plans, engagement focus and priorities and the Committee will consider its engagement capacity and plan further collaboration with the district team.

# LAC Advisory Framework

The National LAC Team updated the Committee on the development of the framework to integrate LAC advice into Fire and Emergency and anticipated timeframes for implementing the framework into Fire and Emergency and the LACs' operations.

#### National LAC Team update

The LAC Team provided updates on the Year One Evaluation of LACs, including initial findings, appointment processes for Tairāwhiti and Chatham Islands LACs and the new, more concise quarterly report for the Board.

# **Board report – Committee time**

The LAC Chair agreed to bullet point content for Northland's contribution to the LAC quarterly report to the Board and members had some committee time at the end of the meeting to discuss this.
