The Otago Local Advisory Committees' (the Committee) second quarterly meeting for 2021-22 was attended by the Committee and representatives from Fire and Emergency's Te Kei Regional Leadership Team.

#### Welcome

The Deputy Chair welcomed everyone to Oamaru, and the Chair opened the meeting with a karakia.

#### Minutes

The minutes of the previous meeting were confirmed by the Committee, as drafted.

#### **District update**

The District Manager presented to the Committee the structure of the new district team, an overview of district priorities and how the District Manager envisions the team working alongside the LAC. The Committee welcomed the new District Manager and encouraged him to use the LAC to connect him with community groups and individuals.

#### Community engagement

The Committee discussed the engagement undertaken within the last quarter. It noted the impact COVID-19 restrictions have had on the Committee's ability to engage, with stakeholders dealing with extra demands and changing priorities.

LAC members engaged with the Clutha Multicultural Group and identified opportunities for developing fire safety materials specifically for new migrants. The District Manager advised he would follow up with the National Communications directorate about this work.

The Committee discussed the focus and effectiveness of engagement to date. Members considered the most effective mechanisms to support Fire and Emergency's district leadership and identified that facilitating connections through direct engagement would provide opportunities to build beneficial relationships with stakeholders.

#### Discussion on engaging with Fire and Emergency volunteers

In response to a request from the Committee for guidance on engaging with volunteers, the District Manager noted that LAC members are a good conduit to understand what additional support volunteers may require. He advised members to plan volunteer engagement in consultation with himself and Fire and Emergency Group Managers, as they are the best contact for engaging with volunteers.

#### LAC Advisory Framework update

The National LAC team presented on a high-level advisory framework to integrate LAC advice into Fire and Emergency. This will provide LACs with direction from strategic and local levels, mechanisms for advice to be considered and flow through the organisation and provides feedback to LACs. Tools and processes to implement the framework are currently being developed.

#### National LAC Team update

The National LAC team updated the Committee on the main findings and next steps of the LAC Year One Evaluation, a new LAC quarterly Board report that will be used from November 2021, and informed members of the appointments process undertaken to increase membership of the Tairāwhiti and Chatham Islands LAC.

#### **Report to the Board**

The Committee drafted the content of its Board report for the quarter.
