The West Coast Local Advisory Committee (LAC) meeting was held at Byte Māwhera – Digital Hub, a community meeting space in Greymouth.

Welcome

The meeting began with a karakia and a welcome from the Chair.

Minutes

The minutes from the Committee's meeting on 21 May were confirmed.

District update

The District Manager spoke to the LAC on district priorities and his vision for the LAC's work alongside the district team, as a voice and support for the community. He noted that he is still working to establish the Coast's risk profile, but is challenging the community risk team team to think from the community's perspective and understand what communities really value.

Community engagement

The COVID-19 lockdown in September resulted in the cancellation of a business forum with agencies and volunteer engagement the Committee had planned for South Westland. Members are however aiming to meet with South Westland businesses in November.

Engagement planning

The Committee agreed to a change of strategy with relation to engagement with volunteers, moving away from the brigade forums members met with last year. In partnership with the district team the LAC is planning a series of events to recognise volunteers and promote volunteerism with employers.

LAC members suggested that the the July 2021 flood that particularly affected Buller may present an opportunity to understand the community's level of resilience and any issues that arose during the response and recovery process. The District Manager will discuss with Buller Council's Recovery Manager what LAC engagement might be useful. Development West Coast's survey on the impacts of the flood on businesses will provide a useful overview of the effects on industry and SMEs.

The Committee is looking to schedule second meetings with the two hapū in the LAC District, Kāti Waewae and Kāti Māhaki ki Makaawhio, in the new year.

LAC Advisory Framework

The National LAC Team explained the LAC Advisory Framework that is currently being developed to integrate LAC advice into Fire and Emergency. The Committee was pleased to learn more details about the framework. Members would like to see 'consideration of advice' referred to rather than 'filtering', to ensure that the independent nature of LAC advice to the Board is retained. They would also like to see a feedback loop to communities included in the framework development and diagram.

National LAC Team update

The LAC Team provided updates on the Year One LAC Evaluation and the appointment processes underway for Tairāwhiti and Chatham Islands LACs. The new, more concise, quarterly Board report template was also introduced.

Board report

The Committee discussed and agreed the content of its quarterly report to the Board.
