# **Committee operations**

### Chair's update

The Chair acknowledged the recent visit to Ngāruawāhia and time with Fire and Emergency staff.

#### **Engagement Session and Planning workshop**

They also covered how LAC engagement fitted into a bigger picture of work for LACs along with analysis of engagements leading to considered and strategic advice to the organisation and the Board.

The committee workshopped their focus and determined priorities for engagement. They also noted potential engagements as part of their tactical approach for each member that link back to the agreed priorities.

#### **District update**

The District Manager gave an update and overview on current issues for the district.

The LAC was briefed on region and district priorities, the district workplan including the key performance indicators, along with identified risks and issues.

The District Manager and Group Managers provided overview on work undertaken in capability building, leadership development, partnerships and relationships, and volunteerism.

Discussed also was where the LAC could support in its role. Highlighted was engaging with local brigades and volunteers and capturing the volunteer experience. The LAC was asked to review the Waikato District 2023-26 Work programme and provide feedback on any gaps.

The Community Risk Manager provided an overview of community readiness and recovery, and risk reduction work for the district.
