Welcome

The meeting opened with a Karakia and the Chair welcoming attendees.

The minutes from the Local Advisory Committee's meeting on 11 November 2024 were confirmed, actions updated, and correspondence discussed.

Chair Update

The Chair provided an update from the Chairs forum in November 2024 and noted other relevant updates for the committee.

The chair raised again the committees concern regarding the current low membership and how this was proving challenging for members to fulfil their commitments in particular with reach across different communities for engagement.

District Update

The District Manager provided the committee with an update on district activities and current risks and issues. The district has a current focus on smoke alarms and has escalated concerns to a national level on smoke alarms in Airbnb properties. Changing demographics continue to be an issue as does the current dry conditions along the West Coast.

Property Update

The Region Manager and National Property Manager Brad Mosby, responded to the committee on issues raised with asset management on the West Coast. The West Coast has 650 facilities, which makes it one of the biggest districts in terms of assets. The district faces challenges with the age and seismic condition of its buildings.

Board Chair Address and Discussion

The Board Chair gave an address to the committee which covered a number of challenges currently facing the organisation. She updated the committee on the Board intended direction to these issues. The address covered several topics including climate change, looking at different options for training, fiscal restraints stemming from a reduction in levy as consumers reduce their insurance spend, considering options around seismic remediation of buildings and the political landscape.

This was followed by an open conversation with the committee on a range of issues directly affecting the West Coast.

Engagement Planning

The committee reviewed its engagement plan, adding in additional engagements before endorsing. Two recent engagements were discussed. Reports will be filed for these post meeting.

Update on the National Volunteering Strategy

The Manager Volunteering gave an update on progress within the organisation's ten-year Volunteering Strategy and looking at the next areas of prioritisation.

Update on the Workforce Operational Capability Project

Brad Mosby and Lia Moon presented on behalf of Chris Lind of the Future Operational Capability project, updating the committee on the project and timelines. The committee was invited to provide feedback to the project team via email: futureoperationalcapability@fireandemergency.nz.

NLAC Updates

The Senior Advisor provided an update on the Whāriki engagement reporting tool rollout and guidance for members when invoicing.

Board Updates

Thank you to the Board Chair for attending the West Coast LAC meeting, and for offering to share the Fire and Emergency report to the Select Committee.

The LAC noted their ongoing concern for low numbers of the committee and the risks to effective engagement across the district.

Recent engagements include Mines Rescue Trust, Family Start and Greymouth division of St John.

General Business

Actions from the meeting were confirmed.

The Chair agreed to write to the National Manager LACs noting the committees concern with low numbers and the challenges this brings moving forward.

The committee agreed to send a letter of thanks to the Board Chair for attending the meeting.

It was noted that the Board Chair has offered to provide the committee with the report by Fire and Emergency to the Select Committee.
