### Welcome

The Chair opened the meeting with a karakia welcoming LAC and RLT members.

## **RLT Update**

The Principal Rural Fire Officer (PRFO) informed the Committee of the District Manager appointment and updated them on the progress of the Tranche 2 district redeployment. The Business Operations Manager (BOM) provided an overview of his position and connection to the LAC.

#### **Chatham Islands Fire Plan**

The RLT consulted with the Committee on the local fire plan. The members provided initial comments and feedback on the plan.

## **Community Engagement**

A member met with Hokotehi Moriori Trust introducing the LAC role and intent for engagement. Hokotehi will meet the Committee in November to discuss their risks and concerns relating to fire and emergencies.

The Committee met with Ngāti Mutunga o Wharekauri Iwi Trust who reiterated their wish to engage quarterly with the LAC.

Introductory emails were sent to Chatham Islands Council and Air Chathams who have agreed to meet with the Committee to discuss risks and issues.

## **Stakeholder Engagement Planning**

The Committee agreed to engage with the Chatham Islands Enterprise Trust and subsidiaries, as they were identified as key stakeholders that fall into various community priorities for the LAC.

The Committee agreed to meet with volunteers at their AGM, alongside the Deputy Principal Rural Fire Officer, to listen to their interests.

#### **Committee time**

Members discussed the results of their self-review they completed in April, identified areas for improvement and discussed what themes they would like the Chair to speak of at the Chair's Forum in June.

## **Hazardous Substances presentation**

Fire and Emergency's Hazardous Substances team presented the hazardous substances response capability development programme to the Committee. The LAC discussed areas where hazardous substances are a concern and what hazardous substances response

capability exists on the Chatham Islands.

# **National LAC Team update**

The National LAC team provided updates regarding the work being done in refining the integration of advice across Fire and Emergency, and the progress of the LAC evaluation.
