Q4- What is the total expenditure of the e-text system in its entirety Nationally over the past 6 years (each broken into individual years total)

Q5- What is the total expenditure on Firefighter and Officer overtime for Wellington, Paraparaumu, Hutt & Wairarapa over the past 6 years (each broken into individual area & years total)

Q6- What is the total expenditure on Firefighter and Officer overtime Nationally over the past 6 years (each broken into individual years total)

Please see attached document for the previously answered questions for years 2017 – 2022. To speed the process, the questions asked would just need the figures for financial year 2022 -2023 added in on an updated document (showing previous years also).

Thank you for clarifying on 13 July 2023 that you would just like us to send you the tables we already sent you on 30 November 2022 detailing the total expenditure of eTXT and overtime in the above locations but updated to include the figures from the 22/23 financial year and new totals.
