Thank you for your email of 13 June 2025, to Fire and Emergency New Zealand, requesting information relating to the current fleet in Te Ihu (Region 4). Your request has been considered under the Official Information Act 1982 (OIA) and our reply is below.

*1. Current Fleet in Region 4:*

- *A list of all current operational appliances in Region 4, including for each vehicle:*
  - *Callsign*
  - *Make*
  - *Model*
  - *Station or base*
  - *Year of manufacture or commissioning into service*

Please find attached, as **Appendix One** to this response, the current fleet in Te Ihu. Please note the following:

- this document excludes brigade-owned and forestry company vehicles which are not managed by Fire and Emergency.
- we only record the year of manufacture (hence its shown as 1 January in the date field),
- we only record the acquisition date not the commissioning date.
- the acquisition date for ex-Rural Fire Authority appliances is shown as 1 July 2017 as the date the Rural Fire Authority acquired the appliance is not recorded.

*2. Fleet Cascade Plans for Region 4:*

- *Details of the current or upcoming cascade plans affecting Region 4, including:*
  - *Appliances due to be cascaded into or out of the region*
  - *Their origin or destination (region/station)*
  - *Expected timeline for these cascades*

Please find attached, as **Appendix Two** to this response, the current fleet cascade plan. Other cascades resulting from the introduction of new appliances have not yet been determined.
